WOW! Sweepstakes Official Rules

NO PURCHASE REQUIRED TO ENTER OR WIN. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING.

Open to legal U.S. residents (and those living in the same household) who reside in a serviceable area of WOW! Internet, Cable & Phone and are 18 years of age or older. Void where prohibited by law.

1. **ELIGIBILITY:** The WOW! Sweepstakes (the "Sweepstakes") is open to individuals who are legal residents of the United States of America, who are eighteen (18) years or older at the time of entry. Employees of WideOpenWest Finance, LLC and its related companies, as well as the immediate family (spouse, parents, siblings and children) and household members of each such employee are not eligible. The Sweepstakes is subject to all federal, state, and local laws and regulations and is void where prohibited by law

4. **ENTRY PERIOD:** The Sweepstakes begins on November 13, 2019 at 12:00:01 a.m. Central Time ("CT") and ends on November 20, 2019 at 11:59:59 p.m. CT (the "Entry Period"). Entries received prior to or after the Entry Period will be disqualified.

WOW! reserves the right to deny any entrant on the content of their entry in our data collection method. Normal Internet access and usage charges imposed by your online service will apply.

5.2 **ALTERNATE ENTRY METHOD: ENTERING THE CONTEST BY MAIL WILL ASSURE YOU THAT WOW! WILL NOT CONTACT YOU BASED ON THE INFORMATION YOU PROVIDE.** In order to enter the Sweepstakes by U. S. Mail, hand print your full name, WOW! account number, address, city, state, ZIP code, date of birth, email address, and daytime telephone number (including area code) on a 3" X 5" card, and mail it, in a #10 envelope with proper postage affixed, to: WOW! There is no cost to enter. Only complete entries will be accepted or entered into the Sweepstakes. Only one (1) entry per person/user account or e-mail Address will be accepted.
